WITNESSES MAY SUE AFTER SON GETS BLOOD

AN Irish health authority may be sued after it decided to give a blood transfusion to a Jehovah's Witness child against its parents wishes.

Their 22-month-old child was hurt in the chest and legs by falling rubble when a car crashed through the garden wall, last month, as he played at his home in Tipperary, which is in the Republic of Ireland.

When his parents refused surgeons permission to transfuse blood during the surgery, the Gardai (Irish Police) enforced Section 12 of the Childcare Act and the blood was given at Waterford Regional Hospital.

National co-ordinator for the Witnesses, Arthur Matthews, said they were disturbed at the decision to put the boy in temporary State custody so surgeons could operate on his injuries.

Mr Matthews said the constitutional rights of the parents as legal guardians were ignored during the incident and the matter was now with the group's lawyers.

"We are taking advice from our solicitors and are considering legal action against the agencies who brought this about.

"These parents were not given the opportunity to discuss alternatives to blood transfusion with doctors and this swept away their constitutional rights as the child's legal guardians," he said.

The Jehovah's Witnesses' lawyers will be instructed to find out the extent of the threat to the child's life and the amount of blood transfused.

"We also understand that the amount of blood transfused was quite small which would indicate that a synthetic product could have been used in its place," said Mr Matthews.

He is now with his family after being transferred to Cork University Hospital.

A spokeswoman for the South Eastern Health Board said it did not comment on individual cases but confirmed that the boy was "making a good recovery".

MAN LOSES SEX APPEAL

A MAN who says he was sexually molested by a fellow Jehovah's Witness member in Augusta, Maine, has failed in his Supreme Court attempt to hold the church responsible.

The court, without comment, let stand rulings that dismissed The Watchtower Bible and Tract Society, and two of its officials as defendants in Bryan Rees' lawsuit

when it met in February.

Rees' lawsuit alleged he was molested by an adult member of the Jehovah's Witnesses congregation in Augusta from 1989 through 1992. The lawsuit said church officials knew that the member had previously had molested another minor but allowed him "to resume activities as an ordinary member or the church."

The church should have expelled or publicly rebuked the member so other members would have been on notice about his conduct, the

lawsuit said.

Rees now lives in Portland and works as a security officer.

Other defendants were dropped from the lawsuit, a decision the Maine Supreme Judicial Court unanimously upheld last October.

"The complaint does not allege that the church affirmatively placed the member in a position of control and supervision of children, such as a Sunday school teacher or youth co-ordinator, or that the church knowingly placed him in a position where he could sexually abuse children within a church setting," the state court said.

In seeking help from the nation's highest court, Rees' lawyer, Michael Waxman of Portland, used

strong words.

"In the context of a religious organisation, or any other group, that allows these predators additional opportunities to prey, to destroy the fragile bodies and minds of children, there is only one way to force a change - make them pay for it."

Marie Hoyle, of Bradford, West Yorkshire, donated a kidney to her husband, Alf, 51, after he had waited nine years for a donor organ. The operation was the first of its kind in Britain to involve Jehovah's Witnesses.

The procedures, performed at St James's hospital, which is in Leeds, were said to be a success, with both patients expected to leave hospital within a week.

The "bloodless" technique relies on a salt solution which increases blood volume during surgery to allow for small losses. Precision instruments are used to lessen the chance of severed arteries, and any blood spilled is cleaned and recycled. Bloodless surgery is a recognised alternative for Jehovah's Witnesses, who cite at least 400 biblical references prohibiting them from receiving blood.

The couple, who have been married for 30 years and have two children, decided to undergo the surgery after Mr Hoyle had been on dialysis three times a week for nine years. He said: "I can't express what a loving thing, what a tremendous thing my wife has done in giving me a kidney."

BUT.

ANOTHER JEHOVAH'S Witness who refused a blood transfusion has been given a "bloodless" liver

transplant.

Ewan Opperman, 19, a computer science student, flew from South Africa for the treatment at St James's hospital in Leeds after surgeons in Cape Town refused to carry out a similar operation. Mr Opperman was operated on without any back up blood and within four weeks was well enough to fly home.

Surgeons believe that bloodless surgery will have profound implications for everyone. It is potentially safer, cheaper and could eventually replace the need for transfusions. About five per cent of surgery is now carried out without extra blood, although it is unusual for there to be no blood at all in thea-

tre as backup.

Stephen Pollard, the consultant who carried out the transplant, has refined the technique which lessens the need for blood, but admitted that having no blood available for transfusion did double the risk of Mr Opperman not surviving the operation. The chances of surviving a liver transplant is 94 per cent. Mr Opperman's risk was assessed at 12 per cent. But he said that for patients who would prefer not to have a transfusion, but who would accept it in an absolute emergency, there was no increased risk.

Mr Opperman said that he never had a doubt about refusing blood. "I always knew in my heart that someone could do the operation

without blood."

Mr Opperman was 16 when he first became ill and short of breath. His family asked surgeons in Cape Town to do a bloodless transplant

but they refused.

"Now Ewan is brilliant. You would never imagine that in such a short space of time he could be so well. It's as if the transplant never happened."

A Jehovah's Witness died after she refused to have a blood transfusion which would have saved her life.

Beverley Matthews, 33, of Stockport, Greater Manchester, was suffering from toxic shock syndrome when she was taken to Stepping Hill hospital with chronic sickness and diarrhoea last November.

She failed to respond to antibiotics and her condition deteriorated

rapidly.

Hospital consultants told her that she would have a 30% chance of survival if she had a blood transfusion, but she and her family refused. Mrs Matthews died several hours later.

At the inquest, held in March, the coroner, John Pollard, recorded an open verdict. He said it was not clear whether the illness had been caused by a natural localised infection or by tampon use.

He said the consultant had been blunt enough to say death was inevitable, but Mrs Matthews and her family had refused treatment. He added that her condition was so serious that a transfusion may not have saved her.

Mrs Matthews was the mother of a four-year-old son, Jake, and lived with her husband, Ian, in Bredbury, Stockport. Her family had been Jehovah's Witnesses for 25 years, although her husband is not thought to share her beliefs.

Mrs Matthews' mother, Marie Vernon, said yesterday: "I was looking for the truth and this religion gave me that. She made the right decision - she had to stick to her beliefs. Beverley was a lovely gir!"

Derek Casey, a spokesman for the Jehovah's Witnesses, said: "We deeply sympathise with Beverley Matthews's family as they come to terms with their sudden and tragic loss."



probably as early as next week. We thought we had another month before they moved.


Can you recommend any literature we could give them or even suggest some way we can still be of benefit to these people (who have become very dear friends and do not in the least act like JW's) in less than a week.

THE AGE OF CONFUSION

It has been said, not without reason, that we live in an Age of Confusion. Since that tragic day in August, 1914, when Mars unleashed the Red and ravenous Dogs of War upon a peaceful world and the thunder of earthquake guns threatened destruction to modern civilisation, the foundation of things appears to be slipping. The post-war dislocations and the severity of the depression left people dazed and uncertain. Vast changes in their lives came almost over night. Millions of people lost faith in the deathless and God-given principles that alone can bring peace, happiness and security to mankind.

With the Nations of the World tossing overboard time-tested and fundamental principles - leaving great Ships of State, deepfreighted with the lives and destinies of millions of people, drifting on storm-tossed, rock-infested seas without chart or compass other than new and untried instruments of moral, social, economic and political navigation — it is inevitable that great numbers of people should find themselves in a state of mental and moral confusion. In this condition they fall easy prey to fantastic schemes to bring about an earthly Utopia and to radical religious movements that normally attract only the lunatic fringe on the edge of society.

We see these manifestations of confused thinking in the temporary

triumph of communism and Dictatorship in some countries, and in the development of such fanatical religious movements as the craze under "Father" Divine that hit the Negroes of Harlem.

However, the most confusing thing I have run across is the philosophy of Joseph F. Rutherford, self-styled Judge and leader of that strange band of pathological purveyors of prejudice and patent prophecies know as the witnesses of Jehovah.

With more patience than I thought I possessed I wandered painfully through the endless repetitions, wild accusations and rambling prophecies contained in "Judge" Rutherford's books, pamphlets and magazines. I must confess that I feel as though I had gone through a mental threshing machine. As a contribution to the Age of Confusion, the "Judge's" writings and lectures stand in a class by themselves. They form a veritable labyrinth of noxious nonsense that has neither definite beginning nor logical end.

In my journalistic career I have crossed swords with many a bigot ranging from the gone and unlamented A.P. Apes of my youth, through the misnamed Guardians of Liberty and the various Cyclops Dragons and Hobgoblins of the Ku Klux Klan - but this is the first time that I have ever attempted to cross swords with a mental flea who jumps from insane prophecies to misapplied and wrongly interpreted biblical passages and back again with all the agility of a frog in a lily pond. That this is a rather mixed metaphor I am well aware, but those of my readers who have read Rutherford to any extent will understand that only a mixed metaphor would be appropriate.

It is difficult to understand exactly what Rutherford means at any given time, and I have a deep, dark suspicion that more often than not he is just as perplexed about it all as his readers must be.

He mixes unwarranted assumptions, brazen falsehoods, agonising prophecies, misapplied biblical quotations and weird interpretations of the Scriptures into an intellectual dish that must give many a Witness of Jehovah a bellyache in the place where his brains ought to be.

It is to be hoped that my readers will not misunderstand the title of this pamphlet or my reason for choosing it. I would have called it "The Rutherford Religion," but the "Judge" insists that his work is not religious – religion being his pet and permanent peeve - and I did not want to offend him and his Witnesses. I do not know what else to call his particular brand of work, and "The Rutherford Racket" appears the proper appellation in more ways than one. The word "racket" is defined in the dictionary as "a clattering, or confused noise," and that definition fits perfectly. In addition, the word means a scheme to make money through deception or force without delivering an equivalent in value; and if selling Rutherford nonsense for coin of the realm isn't a racket, then there is no such animal.

DOCTORS IN STAND-OFF WITH PARENTS OF GIRL WHO NEEDS BLOOD.

A Nicaraguan schoolgirl, could soon die because her Jehovah's Witness parents are refusing to allow doctors to give her a blood transfusion.

The Hazel Borge, who is 10 -years-old was in a car accident on January 10 in which both her legs were fractured and

she lost a lot of blood.

In spite of the parents' wish not to give the child a blood transfusion, do ctors at the hospital went ahead with the procedure to save the girl's life after she went into shock.

Now doctors at the Vele z Hospital in Managua hospital have warned that u nless further surgery is performed on the girl, to amputate one of her legs, she could once again go into shock and

could possibly die.

"The committee in charge of eval uating special cases held an urgent meeting at the hospital to evaluate this special case," said Ramiro Lopez, a director of the hospital. "The committee decided that a blood transfusion is ne cessary, because otherwise the girl will die.

"We told this to the girl's parents, and they came here with legal represent ation from the Jehovah's Witness Organ isation. They signed a document in which the parents are absolutely o posed to the blood transfusion," said Lopez.

"Doctors have spoken with us, and ... the blood is not going to repair my girl's leg. The blood is not the solution. The solution is to repair her leg," said Maria Felix Bermudes, the girl's mother.

Children's court Judge Venicia Ven egas said: "The state must protect chi ldren and teen-agers who are in risky situations. In this situation, it is obvious that the girl is in danger due to the pa rents' decision."

WITNESSES ADVISED TO TAKE BLOOD AND TO KEEP QUIET.

Jehovah's Witnesses who want a blood transfusion should go ahead with the operation but not tell other members of their co mmunity, a doctor has suggested.

The "don't ask, don't tell" policy has been put forward as a way that Jehovah's Witnesses can receive blood, which is against the religious

group's doctrine.

If doctors and patients agree to go ahead with a transfusion without telling anyone, lifesaving treatment



can be received without the person giving up his or her religion, suggests Dr Osamu Muramoto, a regional ethics council member in Portland, USA.

But the British branch of the Jehovah's Witness organisation the Watchtower Bible and Tract Society said by doing so members would be signalling they no longer believed in the group's teachings.

Deciding to take a blood transfu-

sion usually leads to

"disfellowshipping" of the member unless he or she publicly repents.

"If they decide to take a blood transfusion they have decided they don't want to be a Jehovah's Witness any more," said Watchtower press officer Paul Gillies.

Dr Michael Wilks, the British Medical Association's ethics committee chairman, said, referring to Dr Muramoto's proposal: "I don't see where that gets us. It is ethically a bit messy."
